COLLEGE SCHOLARSHIP / CATHOLIC SCHOOL GRANT APPLICATION REQUIREMENTS

- (a) Applicant must be a member in good standing with the Bristol Council #379 Knights of Columbus, or a wife, son, daughter, grandson or granddaughter of a member in good standing of the Bristol Council #379 Knights of Columbus, or a widow, son, daughter, grandson or granddaughter of a deceased member of the Bristol Council #379 Knights of Columbus who was in good standing at the time of his death.
- (b) Applicant must list a selection of accredited colleges, schools of nursing, junior colleges, specialized schools or Catholic School, (Grades 1-12). College enrollment in course curriculum leading to a degree or certificate in a program of no less than two years in duration.
- (c) Applicant must be entering as a college freshman or continuing as an upperclassman. No applications for assistance with graduate studies will be accepted.
- (d) While applications may be submitted by more than one member of the same family, awards will be limited to one per family as funds are available.
- (e) ALL APPLICATIONS MUST BE COMPLETE. Incomplete applications will not be considered.
